

RFP for Baseline Evaluation Consultancy

Project Name: TUINUKE PAMOJA Project Location: Dodoma Region, Tanzania

1. Introduction

The Aga Khan Foundation (AKF) is an agency of the Aga Khan Development Network (AKDN), a group of private not-for profit, non-denominational international development agencies, institutions and programmes that work primarily in parts of Africa and Asia to improve the quality of life of communities in remote and resource poor areas. Reflecting the complex and multi-faceted nature of development, AKF programmes encompasses Education, Health and Nutrition, Early Childhood Development, Agriculture and Food Security, Climate Resilience, Work and Enterprise and Civil Society.

2. About TUINUKE PAMOJA Project

Aga Khan Foundation Tanzania and Tanzania Gender Networking Program (TGNP) with funding from the Embassy of Ireland Tanzania are implementing TUINUKE PAMOJA PROJECT in Dodoma Region of Tanzania. The project covers all seven Districts of Dodoma in Tanzania. The project will run for three years from July 2024 to June 2027. TUINUKE PAMOJA Project with the aim to enhanced collective action for gender equality in Dodoma, Tanzania through community groups, The project will create an enabling environment for grassroots groups to access resources that will facilitate them enact changes in their communities and support a strengthened and diversified women's actions in Tanzania to promote gender equality. The project will work with the community groups identified to capacitate and resource them for collective action for gender equality. This will ensure that local stakeholders are able to mobilize and build up their ability to implement impactful and sustainable gender equality innovations, utilizing friendly resourcing strategies and technical and management capacity to address the gender equality challenges they grapple with on daily basis.

- 3. **Objectives of the baseline study:** The overall purpose of the study is to obtain data that will provide baseline values for all indicators on TUINUKE PAMOJA project expected outcomes, thus enabling AKF and TGNP to monitor and assess progress and effectiveness of the programme interventions during project implementation. The following are the specific objectives of the baseline studies:
- a) Collect quantitative and qualitative data against the projects' Outcome indicators, as outlined in the Performance Measurement Framework (PMF). This data will be used to determine the baseline status of the Outcome indicators and to set appropriate targets for each indicator. Data will be collected again at the midline and endline to determine progress towards meeting these targets.

- b) Collect additional quantitative and qualitative data (beyond the scope of the PMF Outcome indicators) that will help to establish a detailed gender profile to inform project implementation and increase understanding of the context and/or needs prior to implementation.
- c) To use baseline data, as well as lessons from the baseline process, to identify recommendations and propose relevant adjustments to project activities implementation.

The study population will include women, men, elderly, adolescents, boys, and girls residing within the project areas of implementation. The set of indicators for the project and geographical coverage are as presented in the table below.

4. Evaluation Methodology

4.1 Research designs

The baseline evaluation will use both qualitative and quantitative methods. Data will be collected from the project location in Dodoma Region and the respective districts. The selected consultancy firm will prepare the baseline survey methodology and prepare tools wand prepare the sampling frame to meet the objectives of this survey. The baseline survey methodology and relevant tools will be adjusted in consultation with Aga Khan Foundation Tanzania and TGNP, pilot tested and finalized before the study.

4.2 Data

All primary data collected during the course of the baseline survey must facilitate disaggregation by gender, sex, age, disability, education level, location and occupation and other inclusion dimensions. Data triangulation is expected for this baseline survey; the secondary data available is expected to provide additional insight towards the triangulation of the collected data. A range of project documentation will be made available to the selected firm that provides information about the project design, target, indicators and type of beneficiaries. The evaluation firm is required to adhere to Tanzania data protection and privacy policy throughout the survey activities, minimizing the collection of any non-essential personally identifiable information and ensuring secure storage and transfer of data. In addition, the consultancy firm is expected to explore any personal and professional influence or potential bias among those collecting and/or analysing data and mitigating them ethically.

5. Specific Tasks of the consultant during the study:

- Submit a report (inception report) which will include an interpretation of the tasks and methodologies which will be used in the Baseline study.
- Secure necessary ethical approvals for the study.
- Conduct a desk review relevant to the study.
- Develop appropriate tools and instruments for gathering information preferably by using ODK or any other relevant software.
- Onboard and train data enumerators
- Pre-test and adjust the data collection tools.

- Conduct the baseline survey:
- Undertake consultations with key stakeholders and conduct field data collection. ensure quality of data being collected on daily basis.
- Process and analyse the data, write, and present preliminary findings to the project implementation team
- Submit a draft report of the study, receive input and update the draft report.
- Present the draft report of the findings in a stakeholder validation forum for additional comments and feedback.
- Revise and submit the survey report including recommendations to be considered for activities adjustments.

6. Ethical Standards and Safeguarding:

The baseline study must conscientiously abide by AKF's Safeguarding Manual, and all members of the Consultant team must sign AKF's Safeguarding Statement of Commitment upon contracting. The design and implementation of the studies must be in line with the research ethical standards including protection of participants from potential research-related harms, confidentiality, informed consent, beneficence, and safeguarding principles to protect respondents from potential harms such as sexual exploitation and abuse, sexual harassment, and bullying.

8. Key competencies

- Team lead should possess at least a master's degree related t Sociology, Gender Studies, Inclusion, Project Management, Demography/ Population studies, Economics or Statistics and with essential training in Monitoring and Evaluation.
- Other team members should ideally possess multidisciplinary qualifications across gender, social science, social work, and related qualifications.
- Strong experience carrying out surveys and associated qualitative data collection (FGD and KII), particularly focusing on Gender or related thematic areas. Not less than six years' experience.
- Demonstrated experience in employing Open Data Kit (ODK) or other computer assisted research data collection and analysis software.
- Country knowledge and experience in conducting research and impact evaluation studies in Tanzania and the districts applied for is an added advantage.
- Demonstrated experience in safeguarding and working with vulnerable populations.
- Advanced proficiency in English is mandatory. Knowledge of additional languages used in the project area applied for is an asset.

2. A description of how the objectives and deliverables outlined in this assignment will be met (including approach and methodology, timeframe, priorities, role of each consultant, etc.). (30%)

Capability Statement: a description of experience of the individual consultants/consulting organization with the subject matter, including a description of similar experiences by identifying references (organization/agency, contact person, telephone/email contact information, deliverables, etc.) and a CV for each member of the consulting team.
